- Acting for Gree Electric Appliance, Inc. to sue AUX in patent infringement series and patent invalidation cases, successfully defending in the invalidation procedure, maintaining the validity of the patent, and finally winning a successful judgment of 8.4 million yuan in the final instance in the Supreme Court (the case was selected as "Commercial Law" Outstanding Transaction in 2021);

filing the invalid patent of the other party, prompting the other party to withdraw the lawsuit;
